## La Michoacana Meat Market Sweepstakes

## OFFICIAL RULES

At the end of the Promotion Period, one thousand sixty (1,060) winners will be selected as set forth more fully below. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and decisions of La Michoacana Meat Market, 8830 Long Point Rd., Houston, TX 77055 ("Sponsor") which shall be final and binding in all respects.
- 2. Eligibility. Entrant must be a resident of the State of Texas and 18 years of age or older at the time of entry.
